Prior to that she served as President and CEO of Heritage Behavioral Health Center in Decatur, IL since 2002. During her tenure as CEO, Heritage has developed into an exceptional community agency serving persons with mental illness and substance abuse in central Illinois. Prior to becoming President/CEO, Diana served as the Vice President of Client Services and the Chief Operating Officer at Heritage. She began her career in community behavioral health as a clinician at Van Buren County Mental Health Services in Michigan and was awarded her Masters of Social Work degree from Western Michigan University in 1986.

Diana formerly served as President of the Board of the Community Behavioral Health Association of Illinois. She was an active participant of Mental Health Corporations of America where she served as a Board member from 2009-2015. She also currently serves as Vice Chair for the Illinois Supportive Housing Providers Association Board.

She has presented at many local, state and national events on topics ranging from the continuum of housing for persons with a serious mental illness; strategic planning; leadership development; system transformation; integrated care - primary-behavioral health; ACOs and Specialty Care; and complementary and alternative health, as well as a wellness focus on health/behavioral health. She served a guest writer for *Mental Health Weekly* from 2012-2013.

Diana's life-long dedication to improving the lives of persons with behavioral health conditions, her deep understanding of the behavioral health system in Illinois and our nation, and her commitment to recovery and resiliency principles and integrated care will serve DHS well.

# Say It Out Loud



**James Bobo** is a Marine Corp Veteran who has been awarded the Purple Heart Medal. He served during the Vietnam War and has traveled to Cambodia, Japan, The Philippines and Thailand. Born in the projects on the west side of Chicago, James became embittered after the murder of Dr. Martin Luther King Jr. His journey took him from hopelessness, to substance abuse and rehabilitation facilities, to the federal penitentiary, to twelve step groups and to presently serving as an Associate Pastor of Grace & Glory Apostolic Church in Zion, Illinois.

James is an Ordained Elder of the Pentecostal Assemblies of the World; where he serves as Secretary for the Illinois District Council of Christian Education. He is currently seeking a Bachelor Degree in Christian Education from Grand Canyon University so he can meet his goal of becoming an effective Pastor, as he continues to develop a scholarly understanding of the word of God. His personal statement of hope is that *"I can do all things through Christ, who gives me strength."* An avid chess player, James lives in Lake County, Illinois.

**Gloria Centeno** is a native from Puerto Rico. Her journey as a recipient of mental health services and as lead volunteer for "Volunteers in Service to North River" helped her to discover her leadership ability and community organizing skills. Both became influential in the passage of the Community Mental Health Services Act, signed into state law in March 2011. Today, Gloria serves as a Commissioner in the North River Expanded Governing Commission, which has oversight of the first mental health center in Chicago opened with community funds.



Gloria serves as President of Next Steps Board of Directors. She is also a member of the Protection & Advocacy for Individuals with Mental Illness (PAIMI) Advisory Council, maintained by Equip for Equality. She earned a Bachelor's Degree in Psychology from Loyola University Chicago and completed the Psychosocial Rehabilitation Certification Program from Wilbur Wright College. She is certified as a Wellness Recovery Action Plan (WRAP®) Recovery Educator and is pursuing the Certified Recovery Support Specialist (CRSS) credential. Gloria is described by many as a butterfly that spreads wings of strength, hope and perseverance; who inspires and mentors other to follow their dreams. She lives in Cook County, Illinois.
