INFORMATION

Thomas D. Gibbons, State's Attorney in and for the County of Madison, State of Illinois, in the name and by the authority of the People of the State of Illinois, charges that:

ANTIONE D. PARKER

on the 6th day of September, 2014, at and in the County of Madison, in the State of Illinois, committed the offense of:

COUNT I: FIRST DEGREE MURDER (CLASS M) in that said defendant, or a person for whom the defendant is legally accountable, without lawful justification, while armed with a firearm, and with the intent to kill Melvin L. Hayes, shot Melvin L. Hayes in the chest with a semi-automatic rifle, thereby causing the death of Melvin L. Hayes, in violation of 720 ILCS 5/9-1(a)(1), and against the peace and dignity of the said People of the State of Illinois.

COUNT II: FIRST DEGREE MURDER (CLASS M) in that said defendant, or a person for whom the defendant is legally accountable, without lawful justification and while armed with a firearm, shot Melvin L. Hayes in the chest with a semi-automatic rifle, knowing such an act created a strong probability of great bodily harm or death to Melvin L. Hayes, thereby causing the death of Melvin L. Hayes, in violation of 720 ILCS 5/9-1(a)(2), and against the peace and dignity of the said People of the State of Illinois.


COUNT III: FIRST DEGREE MURDER (CLASS M) in that said defendant, or a person for whom the defendant is legally accountable, without lawful justification, while armed with a firearm, and while committing a forcible felony, Armed Robbery, in violation of 720 ILCS 5/18-2(a)(2), shot Melvin L. Hayes in the chest with a semi-automatic rifle, thereby causing the death of Melvin L. Hayes, in violation of 720 ILCS 5/9-1(a)(3), and against the peace and dignity of the said People of the State of Illinois.

COUNT IV: ARMED ROBBERY (CLASS X) in that said defendant, or a person for whom the defendant is legally accountable, while armed with a firearm, a semi-automatic rifle, took property being marijuana, from the presence of Melvin L. Hayes by the use of force, in violation of 720 ILCS 5/18-2(a)(2), and against the peace and dignity of the said People of the State of Illinois.

COUNT V: ARMED VIOLENCE (CLASS X) in that said defendant, or a person for whom the defendant is legally accountable, while armed with a firearm, a semi-automatic rifle, performed acts prohibited by 720 ILCS 550/5, being the felony of Unlawful Possession with Intent to Deliver Cannabis, in that he possessed with the intent to deliver more than ten (10) grams of cannabis, and while committing that offense, the defendant personally discharged a semi-automatic rifle which caused great bodily harm to Melvin L. Hayes, in violation of 720 ILCS 5/33A-2(c), and against the peace and dignity of the said People of the State of Illinois.


