Carol Ann (Edwards) Stucker, 75, died peacefully at 6 p.m., Thursday, July 27, 2017 at her home in White Hall after a hard fought battle with Colon Cancer.

She was born on May 29, 1942 in Jacksonville, one of four children born to Newton Francis and Laura Edith (Wilson) Edwards.

Carol grew up in Jacksonville and graduated with the class of 1960 from Jacksonville High School. Shortly thereafter she married the love of her life, Edward Stucker on June 5, 1960 at the First Baptist Church in Jacksonville, and together their union was blessed with three children and 57 years of marital bliss.



Their married life was filled with love and adventure and took them to several locations throughout the years. They spent the first year of their marriage in Virginia where Edward was stationed with the United States Army.
