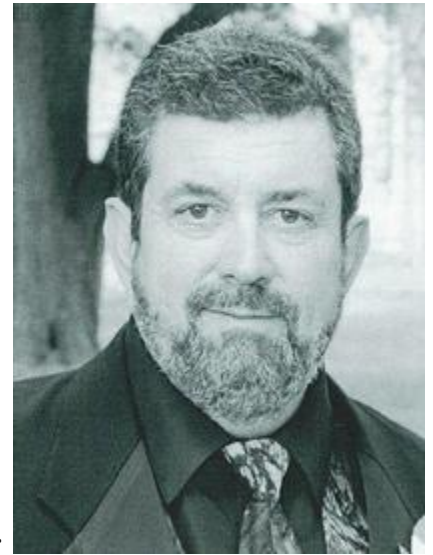




Jeffery Miller
